

# **Conference Speakers**



#### Danielle Baker

Danielle Baker was an active RN (Certified Hospice and Palliative Care) for 20 years and loved her job. She spent the last 17 years caring for her patients in hospice care. In June of 2021, she was coerced into taking the COVID-19 "vaccine" after her former employer issued an email stating a July deadline if the employees wanted to maintain all of their benefits. Having a family to care for, she couldn't afford to lose her job, so she reluctantly took the Pfizer jabs. Within 2.5 weeks after her last shot, she became completely disabled, suffering from severe neurological issues, demyelination of the spine, and getting the diagnosis of transverse myelitis, which her doctor confirmed was due to the Pfizer jab. Since that time, Danielle has been unable to work as she has difficulty completing even the simplest tasks such as walking and self-care.



#### Justin Baker

Dr. Justin Baker (Occupational Therapist), OTD, OTR/L, BS, CFPS has 14 years of clinical experience. Earning a Doctorate degree from Kettering College of Medical Arts and Bachelor's degree from Wright State University, he devoted significant time working with the aging population, experiencing varying degrees of disability.

He has specialized in neurological rehabilitation, orthopedics, and acute care as well as cared for the pediatric population. His expertise as a clinician allows him to document performance skill deficits and the impact on a person's ability to function in daily activities to determine level of disability.

#### Russ Barger

Russ Barger is a Nebraska attorney who engages in civil litigation, primarily. Sullivan Law provides legal services for clients engaged in general litigation, estate and business planning, personal injury, disability and covid-related litigation. There are only a couple of firms that took any interest in representing students, employees and companies subjected to covid-related mandates, of which Sullivan Law is the most active. At this point, Sullivan Law is active in two student mandate cases and one wrongful death case.

She is a certified public health nurse who specialized in ER Nursing. She conducts research, publishes reports and speaks nationwide to civic and medical organizations. She was listed on *Modern Healthcare's* 2009 "100 Most Powerful People in Healthcare." Her efforts in Washington DC led to a federal consent law, a nationwide "Truth about HIPAA" campaign, parents' rights lawsuits, and The Wedge of Health Freedom. Her "Health Freedom Minute" airs on over 800 radio stations in 47 states. She testifies regarding legislation, meets with members of Congress, is quoted as a resource by media, and her commentaries have been published in *The Daily Caller, Star Tribune, THE HILL, Townhall, Wall Street Journal* and *Congressional Record* ("Blame Congress for HMOs").



Tom Connors Mendenhall Law Group Lawyer/Attorney

Tom Connors graduated from John Carroll University, where he studied sociology and philosophy. He then went on to study law at Case Western Reserve University and Cleveland State University. After graduating from law school, Tom served on active duty as a prosecutor, defense counsel, and command advisor in the JAG Corps of the United States Navy. Tom is a retired Commander in the United States Naval Reserve. Prior to joining The Law Offices of Warner Mendenhall, he was a partner at Black McCuskey, Souers, Arbaugh in Canton for over 30 years.

She earned her master's degree and graduated from LHU of Pennsylvania PA program in 2003 and has been a practicing PA since. She was employed in a leadership position in a large hospital system along with practicing full time as a hospitalist PA and taught PA students throughout her career. After 15 years of service working in this health system including as a front line worker during the covid pandemic she was walked out and fired on October 6th 2021 for reporting covid vaccine side effects to the vaccine adverse event reporting system which federal law requires healthcare workers to do. VAERS is our nations early warning system for assuring the safety of vaccines in this country and without proper reporting, enforcement of reporting and education of the health care workers that are required by law to report, we cannot claim that vaccinations are safe and effective.

She is nationally known as the VAERS whistleblower and first appeared and told her story on "The Highwire" with Del Bigtree. This gained her national attention and since that time she has been all over the country speaking and educating the public about her story, the VAERS system and trying to bring justice for the vaccine injured. She is actively pursuing justice of her own by being the first person in history to file a false claims lawsuit trying to hold the health system that refused to file mandatory reports to the VAERS system accountable and to also hold them accountable for wrongfully terminating her for doing so.



#### John Davidson

Magic Feather Inc. President | Creative Director Valencia, CA

John Davidson is a journalist, marketer, filmmaker, and CEO of Magic Feather Inc. and Magic Feathers Corp as well as a member of the advisory board of the Free Press Foundation. With a 30-year media career working for networks like CNN, ABC, and Discovery, John has devoted decades to learning the ins and outs of the film and television industry. In 2020 Davidson created public service announcements for networks in support of healthcare workers.

Davidson recently created the self-funded, award-winning documentary, 'Epidemic of Fraud', which details the bizarre lengths public health officials took to declare a drug similar to tonic water. View the documentary and support his work at BrokenTruth.TV.



Brianne Dressen, a previously healthy preschool teacher and mother of two, was severely injured after participating in AstraZeneca's clinical trial in 2020. After a misdiagnosis of "anxiety due to the Covid vaccine" by her home medical team, the National Institutes of Health (NIH) diagnosed her with "post vaccine neuropathy." She now deals with a life-long battle with debilitating and progressive neuropathic condition.

While witnessing a growing community of vaccine-injured individuals that continue to struggle to attain help or acknowledgement from the drug companies or the government, Dressen co-founded a nonprofit organization dedicated to assisting those affected. React19.org aims to provide physical, emotional and financial support to people suffering lasting adverse events after Covid vaccination. She is leading a landmark lawsuit against AstraZeneca, a first of its kind in the United States. She also is a co-plaintiff in a censorship lawsuit against White House officials, HHS, CDC and Stanford.

#### Ray Flores



Ray Flores, JD has a reputation for being one of the most innovative attorneys in the Health Freedom Movement. He has brought many ground-breaking cases; suing the President to pause vaccine mandates to conduct a control group study, suing the Mayor of New York to end mandatory PCR testing for students, suing the Department of Defense for the death of a civilian by a COVID-19 vaccine, suing the FDA for rushed authorization and approval of Covid-19 vaccines. He was an attorney of record on the CHD v. Rutgers vaccine mandate appeal in the 3rd Circuit, and most recently brought suit against the National Park Service for its cashless policy at several of its locations. Beginning in the 1980's he became a strong leader in the natural products' business. For the past several years he has aggressively fought to preserve our health and our freedoms.

#### Jeremy Friedman



Jeremy Friedman is a sole practitioner in Oakland, California, with a focus on False Claims Act, civil rights and attorneys' fees litigation. In his 35 years of private practice, Mr. Friedman has extensive experience under the False Claims Act at the trial and appellate levels, with primary responsibility in more than two dozen qui tam cases, and he has served as fees counsel and/ or consultant in dozens of other such cases around the country. He is currently co-counsel in an employment class action challenging the University of California mandatory injection policy under the California constitutional right to privacy and bodily autonomy.

#### Major Michael Gary

CBRN expert with 15 years experience in CBRN, 25 years military service Specially trained to detect Chemical, Biological, Radiological and Nuclear threats. Michael Gary petitioned the Military for a Religious Accommodation Packet (Dec 2020) knowing that the Covid gene therapies (so called vaccines) would soon be forced. The Maine

Army National Guard performed an investigation on Michael and charged him with being a domestic/extremist based on his conservative/biblical world view and for refusing the experimental COVID shot. Michael Gary currently works for the Truth for Health Fdn and its Military Advisory Council.

Sujata Gibson is a veteran civil rights attorney who has been active in the medical freedom movement for over a decade. She is the principal attorney at the Gibson Law Firm, PLLC, a boutique law firm specializing in civil rights and medical freedom. Ms. Gibson has brought multiple class actions and impact litigation lawsuits, representing thousands of employees and students whose civil rights were violated by unlawful COVID-19 policies. Over the past year, she won several high-profile victories in this area, including a multi-million-dollar lawsuit on behalf of New York City teachers denied religious accommodation from the Covid-19 vaccine, and a landmark decision overturning the New York State mandate for healthcare workers, which allowed 34,000 healthcare professionals to return to work. Most recently, Ms. Gibson won an appeal in the Second Circuit Court of Appeals on behalf of a disabled child who was denied reasonable accommodation from the ritigation practice, Ms. Gibson teaches part time at Cornell Law School in the area of civil rights and movement law.

#### Miriam Grossman, MD

Miriam Grossman, MD is board certified in child, adolescent and adult psychiatry. The author of five books, including You're Teaching My Child WHAT?, and Lost in Trans Nation, Dr. Grossman's work exposing the origin and hazards of the sexuality and gender industry has been translated into eleven languages. She has testified in Congress and lectured at the British House of Lords and the United Nations. She is featured in Daily Wire's What Is A Woman?, Fox Nation's The Miseducation of America, and many other documentaries. Her expert psychiatric opinion is sought for witness testimony and court reports.

Harry Haury, USA Chairman, has been involved with elections for decades, including consulting on the design and authoring of the Help America Vote Act (HAVA) of 2002. He has worked extensively with the US military, the Department of Homeland Security, and the intelligence community. He is a recognized subject-matter expert on cybersecurity forensics, attack, and defense. He was directly involved with elections systems analysis after the 2020 election where he was the first to advocate focusing on the obvious and massive election misconduct. He submitted expert testimony in several election challenges in 2020, including testimony filed before the Supreme Court.



#### Mary Holland

Children's Health Defense President

Mary Holland, J.D. CEO Children's Health Defense. As CEO of Children's Health Defense (CHD), Mary Holland has been involved in the vaccine choice and health freedom movement for over two decades. "Once I learned about the extreme liability protection that industry and healthcare providers enjoy and the suppression of accurate science and information about vaccine risk and injury, I understood the need for immediate radical systematic change period.

Like CHD, Holland seeks to end the epidemic of chronic childhood disease, hold those responsible accountable, and create safeguards so that these epidemics never happen again. Through its education advocacy, litigation, and research, CHD challenges federal and state governments, pharmaceutical companies, corporations, and corporate regulatory agencies to end the practice that is harming Children's Health in the age of COVID, CHD's mission to protect health and essentially infants' and Children's Health has never been more critical.

Before joining CHD staff in the fall of 2019. Holland directed the Graduate Lawyering Program at NYU School of Law for 15 years and lectured at the Columbia Law School on international human rights advocacy; she frequently testifies in state legislatures around the country to retain or expand religious medical and philosophical exemptions to vaccine mandates. Holland has authored many vaccine law and policy articles, co-authored two books on vaccines, Vaccine Epidemics and The HPV Vaccine On Trial: Seeking Justice for Generation Betrayed,and was an editor on Turtles All The Way Down: Vaccine Science and Myth.

#### Lyndsey House

Lyndsey Nicole House, RN is a registered nurse who has been actively sharing her experiences and advocating for those who have suffered vaccine injuries. A healthy, former 3-sport athlete is now disabled at 38 and can no longer work. Until recently, Dr Marik was a tenured Professor of Medicine. Dr Marik has written over 500 peer reviewed journal articles, 80 book chapters and authored four critical care books and the Cancer Care Monograph. He has been cited over 57 000 times in peer-reviewed publications and has an H-index of 114. He has delivered over 350 lectures at international conferences and visiting professorships. He has received numerous teaching awards, including the National Teacher of the Year award by the American College of Physicians in 2017. Dr. Marik is the co-founder of the Front-Line Critical Care Alliance (FLCCC).

Warner Mendenhall is co-founder of Freedom Counsel and owner of Mendenhall Law Firm. Warner has been active politically all his life. Beginning with two terms on Akron City Council in the early 1990s, Warner has helped citizens fight corruption and the abuse of power by local governments throughout Ohio. During his time on the city council, Warner felt that the city law department was not giving him accurate answers so he went to law school. After getting licensed in the late 1990s, Warner won his first cases exposing block grant fraud and defending Charter Amendments in Akron and knew that he had found his calling.

Since then, Warner has been building a mission-oriented practice to hold local, state government, and corporations accountable. Anchored by a passion for helping to give ordinary people the power to stand up to government abuses, corporate fraud, and bank malfeasance. Being driven by the idea of providing high-quality service to those in need of legal help, his firm and areas of practice have grown over the years into many areas.

#### Jim Moody



James (Jim) Moody began his practice in 1979, first training as an associate at Hogan and Hartson and then moving on to specialize in public interest law at Capitol Legal Foundation. Following four years at the Massachusetts Institute of Technology, earning bachelor degrees in computer science and management science, he graduated from the Georgetown University Law Center in 1979, where he was Editor and Board Member of the Georgetown Law Journal. At the Capitol Legal Foundation, he worked on cases involving economic liberties, civil rights, and a broad array of deregulation policy and litigation. He then started a new public interest firm, Advocates for a Competitive Economy, in 1986.

Mr. Moody's practice involves representing whistleblowers, including "qui tam" cases under federal and state false claims acts; applied constitutional economics; civil rights cases-especially those involving the First Amendment; consulting in science, nuclear nonproliferation, and security policy; the representation of small businesses defending against government investigations, enforcement actions, and prosecutions; and cases brought under the National Vaccine Injury Compensation Program. Among Mr. Moody's most notable clients have been Linda Tripp (in the investigation brought by Independent Counsel Ken Starr involving Whitewater and the White House), Dr. Andrew Wakefield (a British doctor who asserted a connection between a novel form of bowel disease and autism), and General William Westmorland (in his defamation against CBS). His charitable work has included serving on the Board of Trustees (Corporation) for MIT and several Visiting Committees; on the Board of Directors for the MIT Alumni Association; and as a Director of the National Autism Association, Safeminds (a research think tank focused on autism), and the Strategic Autism Initiative.

#### Mervl Nass. MD

Meryl Nass, MD is an internal medicine physician and was the first person in the world to prove that an epidemic (anthrax in Rhodesia) was due to biological warfare, in 1992. She has given 6 Congressional testimonies regarding anthrax, biological warfare, Gulf War syndrome and vaccine safety, and has consulted for the Cuban Ministry of Health, the World Bank and the Director of National Intelligence.

Since the COVID pandemic began, she has written detailed articles regarding the suppression of hydroxychloroquine and ivermectin for treatment of Covid, the coverup of COVID's lab origin, and how the WHO's proposed pandemic treaty and amendments will lead to more pandemics. She is an advisor to Children's Health Defense.

Her medical license was suspended in January 2022 for providing early COVID treatment and spreading alleged vaccine misinformation. She has been writing and speaking on all things COVID, and is now focused on the BioSecurity Agenda of the W.H.O. and its goal to wrest sovereignty from individual nations under the guise of pandemic preparedness.

Alan J. Reinach, Esq. is a civil rights lawyer and Seventh-day Adventist minister who has served as President of the Church State Council, the education, advocacy, and legal services ministry of the Seventh-day Adventist Church in the western United States, since 1994. Reinach directs the education and advocacy programs of the Church State Council, primarily focused on the preservation of religious freedom for all peaceful people of faith, as well as preserving the separation of church and state.

Reinach also directs the legal services ministry of the Church State Council offering legal assistance to persons of all faiths complaining of religious discrimination in the workplace. His most notable achievement has been obtaining a 9-0 ruling from the Supreme Court in Groff v DeJoy, establishing vigorous protection for those needing religious accommodation in the workplace.

She was called to action to help college students (she has two of her own) fight these tyrannical policies. Shortly after COVID-19 vaccine mandates were announced, she co-founded NoCollege-Mandates.com to help fight and end college vaccine mandates for all students. While the fight continues, as of there today, there remain only 30 colleges with COVID-19 vaccines mandates. Her organization has accomplished much but it is not over for this pandemic and the ongoing need to protect medical freedom and informed consent for college students everywhere.


